2.00pm <u>Wendy Scrase</u> BCU Research and Development along with <u>Rebecca Burns</u>.

Wendy and Rebecca talked about Health and Care Research Wales funded and overseen by the Welsh Government. Clinical trials units at Swansea, South East Wales and North Wales organisation for randomised trials in health. They also discussed PiCRIS (primary care research incentive scheme) which commenced in 2012. This provides funding and offers support with a balanced portfolio in practices. 17% of the 462 Welsh practices have applied. PiCRIS encourages practices to commit to deliver an agreed number of studies per year, to develop a balanced portfolio, receive ongoing guidance from a mentor, cascade GPC training through staff. Develop an infastructure and work towards RCGP research ready accredication.

Results so far are very encouraging and 65% of adults say they would be willing to take part.

GPs scored 7.6 out of 10 (Consultants scored lower) with patients describing their GPs as very trustworthy.

Wendy stated that they work closely with SAIL.

2.45pm Rachel Whitehall latest update. Rachel was unable to attend, but kindly sent an update regarding the OPD Mission. A Health Analytics Company has been brought in to try to solve the follow up mis management that has occurred. There are still 48,000 patients due a follow up. Dr K Jones felt it would be appropriate for patients to ring a dedicated line if they feel they want to be seen. Dr E Jessup to write regarding this.

Dr D K Banerjee feels that the pay increase from £53 to £70 (weekends £90) has not impacted on recruitment.

5. <u>BETSI CADWALADR UNIVERSITY HEALTH BOARD</u>

(b) <u>Maternity leave reimbursement</u>.

PW stated that there is a difference in the wording between the Welsh and the English SFE.

11.3 In any case where a contractor actually and necessarily engages a locum (or more than one such person) to cover for the absence of a GP performer on ordinary or additional maternity leave, paternity leave or ordinary or additional adoption leave, and—
(a) the leave of absence is for more than one week;

- (b) the performer on leave is entitled to that leave either under—statute;
- (ii) a partnership agreement or other agreement between the partners of a partnership; or
- (iii) a contract of employment, provided that the performer on leave is entitled under their contract of employment to be paid their full salary by the contractor during their leave of absence;
- (c) the locum is not a partner or shareholder in the contractor, or already an employee of the contractor, unless the performer on leave is a job-sharer; and
- (d) the contractor is not also claiming another payment for locum cover in respect of the performer on leave pursuant to this Part,

then subject to the following provisions of this Section, the LHB must provide financial assistance to the contractor under its GMS contract in respect of the cost of engaging that locum (which may or may not be the maximum amount payable, as set out in paragraph 11.5).

GPs should inform the Coroner of any death involving a patient subject to a DOLS (Denial of Liberty Safeguarding Orders) order. However, GPs are often not aware that the patient has a DOLS order in place. In light of this, the neg team had further discussion at GP Forum regarding solutions including whether HBs could provide practices with lists of patients under these orders. The potential bureaucracy attached to practices receiving repeated updates etc led us to look at alternatives. Our recommendation is for the GP to simply check with the Care Home whether the patient was subject to a DOLS before issuing the certificate. The Care Homes keep up to date lists.

(1) Behcets Syndrome.

The aim of the Centres of Excellence is to ensure that patients with Behcet's syndrome can access timely diagnosis and receive optimal treatment across the country. They provide a "one stop" service, aiming to provide the best care from diagnosis for this rare, chronic disease.

The Centres are based in City Hospital, Birmingham, Aintree University Hospital, Liverpool and the Royal London Hospital, London. Each hospital has specialists with relevant expertise and provides multidisciplinary teams that work together within each hospital and with the other Centres to further improve the care of Behcets syndrome patients.

They are funded by the NHS after a successful bid by the Clinical Leads of each Centre of Excellence and the <u>Behcets Syndrome Society</u>.
